**Operative Time:**

Operative Time means the insured person is covered under the insurance contract as per Schedule of this Policy and the insured person's individual certificate of cover issued to the insured person with a unique certificate number;

**I. Personal Accident insurance incl. Medical Expenses:**

This insurance cover includes the insured person's travelling to the destination of an insured event from the moment the insured person starts their journey from their residence until the earlier of

- midnight local time on the day they return from the insured event venue to their residence, or
- 48 hours after leaving the insured event venue including uninterrupted travel.

**II. Travel cancelation and curtailment insurance:**

This insurance cover starts with the date of registration of the insured person's participation at an insured event, but at the earliest with the date of premium payment.

This insurance cover ends with leaving the insured event venue after the conclusion of the insured person's participation.

**Validity of Insurance Cover:**

This insurance cover is valid worldwide.

Business trips to destinations qualifying as "critical" risk according to AIG's ranking will be subject to the insurer's pre-approval. Business trips to destinations falling under the risk assessment categories "minimal" to "high" risk are covered within this policy.

**Amendments:**

1. The trip cancellation cover extends to registration fees for insured events as if they were TRAVEL ARRANGEMENTS.
2. The definition of IMMEDIATE RELATIVES applies to the race pair partner.

**Exclusions:**

As per policy conditions "Group Plus Business Travel Insurance GENERAL CONDITIONS"

In addition to the general exclusions according to the above-mentioned general terms and conditions, this policy does not cover any claim in any way caused by or resulting from:

- a) Coronavirus disease (COVID-19);
- b) Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);
- c) any mutation or variation of SARS-CoV-2;
- d) any fear or threat of a), b) or c) above.

This policy will not cover any loss, injury, damage or legal liability sustained directly or indirectly by any SDN – Specially Designated Nationals, any terrorist or any member of a terrorist organization, any narcotics trafficker, or any purveyor of nuclear, chemical or biological weapons.

**Sanctioned Territories:**

The Insurer shall not be deemed to provide cover and the insurer shall not be liable to pay any claim or provide any benefit hereunder to the extent that the provision of such cover, payment of such claim or provision of such benefit would expose the Insurer, its parent company or its ultimate controlling entity to any sanction, prohibition or restriction under United Nations resolutions or the trade or economic sanctions, laws or regulations of the European Union, Switzerland, United Kingdom or United States of America.

This quotation does not include exposure and no exposure is expected over the course of the policy period for The Republic of Belarus; or the Russian Federation as recognized by the United Nations (or their territories, including waters or protectorates where they have legal control; legal control shall mean as recognized by the United Nations).
